SECTION 32.9: TABLE OF PERMITTED USES

The following uses shall be permitted in the districts as indicated herein. Uses are permitted by right in each district that has an "X" in the column corresponding to the district. An "S" indicates that a Special Use Permit is required (see Section 32.13). A "C" in the column indicates that a particular use is permitted through the Conditional rezoning process. **(Amendment adopted June 3, 2003)** A blank space in a column indicates that the use is prohibited in that district.

All uses are subject to all sections of this chapter, including the applicable special requirements as indicated in the table. Upon receiving an application for a building permit for a use not specifically listed in this section, the Building Inspector shall determine the listed use to which it is most similar and shall enforce for the requested use all requirements applicable to the similar use. When an application for a building permit is received for use not specifically listed and the Building Inspector has determined that said proposed use is not similar to any other specifically listed uses, the proposed use may be the proper subject for a Special Use Permit in an I-3 zone, and the procedures for Special Use Permits set forth in Section 32.13 shall be followed.
